

2019 Hardwick Community Fair Tractor Pull Rules

ALL DECISIONS MADE BY PULL OFFICIALS ARE FINAL. DISAGREEING WITH A PULL OFFICIAL WILL RESULT IN DISQUALIFICATION FOR THAT CLASS AND DAY IF DEEMED NECESSARY.

1. All drivers will wear a helmet.
2. All tractors will have wheelie bars strong enough to support the tractor that will not let the bottom of the front tire exceed 14" from the ground.
3. All tractors will have a hitch that is adjustable. We run 13" hitch height to top of your hitch surface.
4. All front frames will not exceed 20" from the furthest front part of the tractor. All tractors must be able to get on our scale with weights they weighed in with.
5. We run 100' tractor with the top 3 past that are entered into the pull off at the end of each class. If you don't go past 25' you can drop back to the end of the class.
6. Maximum tire size will be 26"x 12"x 12" except if you have an outlaw they run 31.5". No tire chains. Cut tires are allowed.
7. All drivers WILL put the tractor in neutral and PUT their hands up until the sled hooker has hooked the chain.
8. Winning tractor WILL be reweighted after class. If the weight is not correct, then the second-place tractor will be the winner.

9. If we have large turn-out of pullers, they can enter ONLY 2 classes with the same tractor. You can enter as many classes as you want with different tractors. No more than 2 tractors per driver in the same class.
10. Any tractor can pull in any class. If they are pulling for points, then wins will not count unless they belong in the class.
11. All tractors must remain inbounds at all times. Any outside contact or assistance from anyone, including officials, will result in disqualification.

CLASSES:

Hardwick Stock: 1100, 1400, 1600 lbs

- Tractor can have a motor no bigger than 25 HP. You can run single cylinder, V twin, or Snowmobile engine.
- Must have proper sheet metal, hood, seat, and fenders.
- Can run ATV tires.
- No tires bigger than 26" x 12" x 12".
- Must conform to the General Tractor Puller rules.

Light Limit V Twin: will use NQS Rules.

Outlaw Class: will use NQS Rules.

Any other tractor class not listed above must be built to specific rules either NQS or other club's rules.

Releasor agrees to indemnify the **Releasees** and each of them from any loss, liability, damage or cost **Releasees** may incur due to the presence of **Releasor** in or at the Hardwick Community Fair whether caused by the negligence of the **Releasees** or otherwise.

Releasor assumes full responsibility for and risk of bodily injury, death or property damage due to negligence of **Releasees** or otherwise while in or at the Hardwick Community Fair, and while competing, officiating in, working or for any purpose participating in the Hardwick Community Fair Tractor Pull.

Releasor agrees that he or she has adequately prepared for the Hardwick Community Fair Tractor Pull.

Releasor expressly agrees that this release, waiver, and indemnity agreement is intended to be as broad and inclusive as permitted by the laws of the Commonwealth of Massachusetts, and that if any portion of the agreement is held invalid, it is agreed that the balance shall; notwithstanding, continue in full legal force and effect.

Releasor, being of lawful age, in consideration of being permitted to participate in the Hardwick Community Fair Tractor Pull, for himself or herself, his or her heirs, executors, administrators, and assigns, releases and discharges the Hardwick Community Fair Association, Inc., its heirs, administrators, and executors of and from any and every claim, or right of action, of any kind, either in law or in equity arising from any bodily injury or personal injuries known or unknown, death and property damage resulting from any accident which may occur as a result of competing, working, or for any purpose participating in the Hardwick Community Fair Tractor Pull or any

activities in connection with the Hardwick Community Fair Tractor Pull, whether by negligence or not.

Releasor further states that he or she has carefully read the above release and knows the contents of the release and signs this release as his or her own free act.

Releasor further releases all officials and professional personnel from any claim on account of first aid, treatment or service rendered during his or her participation in the Hardwick Community Fair Tractor Pull.

This release contains the entire agreement between the parties to this agreement and the terms of this release are contractual and not a mere recital.
